# Job Description:

They will provide effective leadership and oversee the daily operations of our pool, swim programs, summer pool activities, and lifeguard staff. They will create a memorable Member experience based on high levels of safety, friendly service, and quality aesthetics.

# Job Duties:

# Members

- Maintains a courteous and helpful relationship with Members and guests
- Supervises registration of Members and charging of guest fees
- Enforces Club rules of safety, conduct and decorum
- Plans, directs and attends seasonal special events
- Represents the Club in all swim program related activities
- Assists in rendering first aid according to the standards established by the American Red Cross and American Heart Association

# Programs

- Promotes, coordinates and assists coaches in the summer swim team program
- Schedules and teaches private and semi-private lessons in a safe and responsible manner.
- Develops program for swim lesson/clinics; dates, class times and fees

# Staff

- Hires, trains, supervises and evaluates all pool staff, lifeguards and coaches
- Delegates responsible senior lifeguards to open and close the facility daily
- Holds staff meetings and regular training sessions for lifeguards weekly work schedules and rotation schedules for lifeguards and coaches
- Completes, processes and maintains all pool staff paperwork and payroll in a timely manner

## Maintenance

- Oversees daily pool operations to adhere to local and state regulations
- Maintains the pool and surrounding areas in a high standard of cleanliness
- Develops a working knowledge of the pool pumps and chemical feed systems Orders and maintains a sufficient inventory of chemicals and reagents.
- Keeps all required records concerning pool chemicals, pH and chemical levels and accident reports.
- Alerts maintenance department of problems and needs which cannot be solved by current staff
- Contacts commercial pool support when needed for repairs
- Prepares the pool for health department inspection for spring opening
- Closes and winterizes the pool, post season

## Off Season

- Develops and communicates swim programs for the next season
- Inventories existing pool safety and mechanical equipment
- Orders supplies and replaces equipment as needed
- Maintains all professional certifications

## **Education/Qualifications**

- Minimum of 2-3 years' pool management experience
- Minimum of 2-3 years of coaching/teaching experience

## Certifications

- Nationally recognized training standard for Lifeguards, Lifeguard Instructor and water safety instructor
- Standard First aid and CPR for the Health Care Provider / Professional Rescuer
- CPO and/or LAFT Pool Operator's License (within 30 days of hire)
